The undersigned hereby makes, constitutes and appoints each of Robert DeAversano, Steven Abrams, Valerie Delp and Irina Abbas, or any of them acting singly, and with full power of substitution and re-substitution, the undersigned's true and lawful attorney-in-fact (each of such persons and their substitutes being referred to herein as the "Attorney-in-Fact"), with full power to act for the undersigned and in the undersigned's name, place and stead, in any and all capacities, to:

1.
